

CHAIRMAN'S CHAT - NOVEMBER 2014

Thank you all for electing me Chairman at the recent AGM in October. For the benefit of those who don't know, I collect postal stationery newspaper wrapper of the whole world. In addition, I am currently in the process of compiling a catalogue of newspaper wrappers. The catalogue is very close to completion and I am currently tidying up numerous loose ends.

It's now a long established tradition for the Chairman to describe an item of interest from his collection so I don't propose to make any change on this front.

Compiling a catalogue not only requires one to list the item but also to put a value on it. For popular items, which are often offered for sale, this is not too difficult. When it's some country very low on the popularity rating and the item is scarce then it becomes a problem. I was reviewing the Algeria section of the catalogue recently and was faced with this dilemma. There are just eleven basic different wrappers that were issued. Unused copies of all of these are offered for sale regularly. However, for

used items it's a completely different story. Dr John K Courtis has only recorded eight used items from Algeria in his archive / database of wrappers sold on ebay since September 2003. H&G E1 one copy, E3 two copies, E5 two copies, E6 two copies and E7 one copy.

Whilst going through this review and checking my collection I came across this unusual item of interest (H&G E10, which is one of seven Algeria wrappers with a zero sale on ebay in over 10 years). This item was posted in Oran, Algeria on 31 Jan 1942 using a 1939 issue, 0f10 on 20c wrapper, addressed to someone serving in the French Army, it attracted postage due in Morocco, postmark MEKNES - VILLE NOUVELLE MAROC on 14 Feb 1942. Postage due from any country on wrappers is relatively scarce; and this is the only instance I have seen of a Morocco postage due on wrapper. Who said newspaper wrappers were boring?

However, for the past few years we have been asking for volunteers to fill the posts of Assistant Journal Editor, Publicity Officer and Programme Secretary, without success. Not having these other posts filled puts extra strain on our officers who already work hard for the success of the Society. So if you can help out with any of these roles, please get in touch with the Secretary or another committee member to find out more details of what would be involved.

AGM REPORT

Fifteen members attended the Society's annual general meeting held on Saturday 25th October 2014 at the Royal Philatelic Society's meeting room in London.

Apologies for Absence were received from Edward Caesley, Charles Elgood, Tony Goldstone and Ravi Makhija.

Minutes of the AGM October 2013

These were published in the November 2013 Newsletter (accompanying the special issue of the Society's Journal) and were accepted as a true record of that meeting.

Secretary's Notes

The Secretary told the meeting we did not have a Deputy Chairman for the Society and that the Treasurer has indicated that he will be giving up the role due to ill health, as soon as someone can be found to take over the position. **Neil Sargent** said that we must have a treasurer otherwise the Society could not exist, and asked if anyone present wished to be put forward for either position, but there were no volunteers. [Note. By the end of the day, nobody had come forward offering to fill either post.]

Chairman's Report

Neil Sargent said "This is my final report as Chairman as I hand over the Chair to Jan today. I am proud to have served a term as the Society's chairman and have enjoyed the role tremendously.

We have had a good year with a superb display in March by Alan Huggins of his British Levant stationery which has since been successfully dispersed amongst many collectors. Last October we had a very successful auction with one of our highest totals being achieved.

Both the Tony Chilton and the one-sheet competitions were well supported and hopefully even more members will be encouraged to put up displays.

Our last meeting was at the excellent Swinpex event in June - I even managed to turn up on the right weekend this time!

I would like to thank the sterling efforts put in by other officers including Colin as secretary, John as editor of the excellent journal and Edward as membership secretary.

I would also particularly thank **Alan Ginsberg** as Treasurer who has had to put up with my chopping and changing in finalising auction accounts. He is retiring from the post due to ill health and I am sure we all wish him a speedy recovery.

I would also thank all members for their support and wish Jan as my successor an equally enjoyable time as he becomes Chairman."

Secretary's Report.

Colin Baker said that last year's 21st Anniversary celebrations had gone very well. The meeting with the GBPS was well received, as was the excellent special issue of the Journal to go with it. The meal at the Union Jack Club in the evening was well supported, rounded off with Alan Huggins being made an Honorary Life President.

Treasurer's Report

(Read on behalf of **Alan Ginsberg**) "The accounts for the year ending 31st August show that the society has ended the year with a deficit once again. Based on the numbers, with a total Income of £4565.30 and expenses of £ 5483.95, we are running at

a deficit of £ 918.65 for the year. It is now higher than the deficit from last year which I declared last year was £431.67.

The Paypal account continues to be used by a limited number of our members for payments of subscriptions or auction payments, mainly from overseas. It is of greatest benefit to our overseas members, as it makes payment from anywhere in the world very straightforward. In general the majority of people tend to add 4-5% of the costs to cover the commission charged by Paypal, but in many cases this does not adequately cover those expenses.

A detailed description of the best way to use Paypal should be put onto our website, so that those people who wish to use the site can pay the exact amount owing as well as the applicable commission charged by Paypal, so that we end up with the correct amount for subs or auction payments. By the 31 August 2013, we had a credit of £1292.85 in Paypal.

With the help of **Ed Caesley** who deals with membership of our Society, we have total revenue from membership fees of £2391.58 for this year.

The auction results show that this service to members made a profit this year. The October 2013 auction made £938.47 while the May 2014 auction made £407.80. Our postage float for Journal postage stands at £2275.25 which indicates that we should have enough stamps for coming year. In view of the possible changes to be made with the introduction of e-Journals, we should be able to get by using less stamps for the distribution of our Newsletters.

As in past years, we are having to resort to taking money from our savings in order to keep the bank account balanced. Our Committee will be making proposals regarding the annual subscription fees for the coming year in an attempt to help balance our books.

Neil has done a fantastic job in our auction catalogue. Members are encouraged to offer their surplus material for auction through our Society.

May I take this opportunity to thank Colin Baker and John Barker for their help through the year as well as John Barker and Neil Sargent for their efforts in obtaining advertising revenue and auction commission. It is with sincere reluctance that I have to advise that I will not be able to continue doing the accounts due to ill health. I have asked Colin Baker to try to find someone to take over my position as soon as he can."

A copy of the balance sheet was distributed to members present. One question was asked concerning the increase in room hire fees for 2013/14 against previous years. The current year included the room hire and dinner at the Union Jack Club in November 2013 (but this was largely repaid by members attending the dinner) and the payment in full for the meeting room at London 2015.

Auctioneer's Report

Two auctions as usual were held during the year. The October 2013 results were the very best for a long time, amounting to over £6,900 the vast majority being GB. The Valentine envelopes sold very well, as did the 10 impression QV envelopes. A satisfying sale, with 50 buyers and 19 vendors; again a high number who introduced variety into the lots.

The next sale was held in June this year with a large number of lots again but sales at 50% of the October auction, but better than the equivalent sale in 2013. Number of non GB lots sold picked up marginally but conversion of GB lots was low — potentially due to the more common or modern items that were not finding favour.

All I would ask is that members keep the lots coming in and it is very easy to enter lots. Just put them in an envelope to me with a brief description and a reserve. Our average is about only 11/12 vendors out of the whole membership.

Journal Editor's report

John Barker said to the meeting "Through the generosity of an anonymous donor, I was able to produce a special 44 page issue of the Journal to commemorate the 21st anniversary of the Postal Stationery Society. This special edition carried a two page spread for each of the 16 displays presented to the joint meeting with the Great Britain Philatelic Society at the Royal in November 2013. I am very grateful to all those members who have contributed to the Journal throughout the year. My thanks go to our advertisers who help to keep down the cost of publishing; their support is very much appreciated.

As usual, I appeal for more contributions however small. Please keep me supplied with items for publication over the coming year."

Membership Secretary's report

(Read on behalf of **Edward Caesley**.) "The Society has 203 paid up members with 10 members joining this year. 95% of the new members have joined using the Societies web-site. Since this means that they have an e-mail address I have been sending all the paperwork (5 A4 pages) as e-mail attachments which keep costs to a minimum."

Librarian's report

(Read on behalf of **Chris Howe**.) "Books continue to be requested by members and I loan about ten each year. Wherever possible I send scans to borrowers by email, CD or hard copy. I am also able to answer some members' queries through my contacts with librarians of other UK specialist societies.

Donations from members of books or articles are most welcome, and perhaps requests from members to acquire specific books would also be useful."

Webmaster's Report

Jan Kosniowski said "When I first took over the task of Webmaster, some 18 months ago, I was anticipating completing my catalogue of newspaper wrappers within a matter of months. However that has not happened and all my spare time is still being devoted to the catalogue and not as much as I would wish on the Society's website.

The society website has continued to be updated with the contents of the PSS Journal and details of forthcoming meetings.

The task of adding new pages using articles which appeared in past issues of the PSS Journal has slowly continued, a number of new pages have been added onto the website

The website continues to attract a similar number of visitors as in previous years. Including visits made by search engines, the average has gone up by 40 to about 380 per week. Looking at the activities of the search engines it does appear that they account for some 90% of the visits. This gives a real figure of about 40 visits per week."

Proposed increase in subscriptions

John Barker reported that due to the British Post Office's huge increase in postage for packets going to places outside the UK, he felt there was no alternative but to increase the subscriptions for those members living abroad. He said it now cost £4 per member to send out the Journals and Auction Lists each year to those living in the UK, £14 to those living in Europe and £18 or more for the rest of the world. He proposed the UK rate should remain the same at £18, but members living abroad should pay an increased fee. There was a great deal of discussion about this and following proposals being tabled and voted upon, it was agreed that the fees for overseas members should be as in the table below. A two stage increase was accepted to help members living abroad. However overseas members could elect to receive all the Society's communications (ie the Journal, notices, programme, auction lists etc) via email, paying the same rate as now £18.






KG V REGISTRATION ENVELOPES - WOLVERTON ISSUES

Harold Barstow

I have known for some time that both **RP28 F & G** size registered envelopes can be found with flap type 5 instead of the usual size 6. These are not particularly rare as I have found them frequently. So how could this have happened?

KGV registered envelopes with a minute W under the King's head but a year later the W was erased and replaced by stamps without a W

RP27 & 28 were both were printed at the Wolverton factory.



Mc Corquodale had printed Railway documents since 1840 for the L & NWR Co., but Sir Richard Moon the Chairman, asked Mc Corquodale to set up a new printing factory at Wolverton where a railway works existed. This was to employ young girls whose fathers worked at the railway works where girls were not allowed employment. When these girls married they lost their employment to make room for other young girls.

When in 1878 the works at Wolverton opened; **registered envelopes** and official documents were printed and they continued to print all GB registered envelopes although the flaps said Mc Corquodale printed them, they being the main agents.

Later in 1911 Wolverton printed all sizes of their first

RP27 issues were printed with type 5 flaps, a year later the W for RP 28 was removed. No doubt the authorities thought this was advertising. These were printed with type 6 flaps.

A small remainder of envelopes of the blank F & G sizes were first printed with the new indices with flap 5.

My G size RP 28 with flap 5 are EF (m) BF DF (u)

F size **RP 28** with flap 5 are CF EF EF (m) DF and FJ used.

I cannot fully explain FJ (June 1915). It is possible that a further batch of the first issue had been found and issued.

The larger size envelopes seem not affected. (so far)

TONY CHILTON COMPETITION


NEW ITEMS REPORTED

Envelopes - Stamped to Order Issues Queen Elizabeth II In the last issue George King reported ES167, size DL, with the printed logo of the National Assembly of Wales. He now reports an example of ES174b, size C5, with the logo of the Scottish Parliament with 26mm. Stamp and pale yellow phosphor (Fig. 1). He also reports examples of ES160e, size DL and ES173, size DL & C5 with 25mm. Stamp in a brownish black shade.

Whilst on the subject of postal stationery used by Parliamentary bodies I recently came across a large size manila House of Commons envelope used in 1987 which I had not seen before. This envelope, which has the Portcullis symbol on the flap, measures 230 x 360mm. has a 23 x 23mm octagonal 1st class NVI type E3a printed in greyish black with a thin white frameline without phosphor bands (Fig. 2). This size does not match the later large size manila QEII envelopes used by both the House of Commons and House of Lords which measure 230 x 325mm. but would have been appropriate for Imperial foolscap size paper. George King has a similar envelope used some ten years later (Fig. 3).

Coincidentally **Douglas Muir** Senior Curator of Philately at the British Postal Museum & Archive showed me a number of large size manila paper Parliamentary envelopes which had recently come to light, not all of which seem to have been recorded to-date in issued form. These are listed below and over page courtesy of the British Postal Museum & Archive, together with the later issued types of larger size manila QEII envelopes with NVI types E7, E8, El 1 and E12 seen to-date.

(NB. Unused DL envelopes with airmail etiquettes for the House of Commons and House of Lords have been reported many years ago by **John Holman**, but as far as I am aware no issued used examples appear to have surfaced to-date).

Stamped to order Parliamentary envelopes with octagonal 1st class NVI stamp type E3a, with 'House of Commons' and with Portcullis' symbol at top left on front..

Manila paper, size 300 x 403mm., greyish black NVI stamp (23.5 x 23.5mm.), no phosphor bands, with 7mm. 'Recycled Paper' symbol at bottom left.

Manila paper, size 300 x 403mm., as previous envelope but with blue 'By air mail / Par avion' etiquette at top left, 'UNITED KINGDOM' under NVI and 'THIS ENVELOPE TO BE USED FOR / APPROVED EC DESTINATIONS ONLY' and 12mm. 'Recycled Paper' symbol at bottom left.

Manila paper, size 255 x 380mm., black NVI stamp (23.5 x 23mm.) with narrow neck, no phosphor bands, with 12mm. 'Recycled Paper' symbol at bottom left.


Manila paper, size 255 X 380mm., black NVI stamp (24 Xx23.5mm). no phosphor bands, with 15mm. 'Recycled paper' symbol at bottom left.

Manila paper, size 230 x 325mm., black NVI stamp (23 x 23.5mm.), no phosphor bands, with 15mm. 'Recycled paper' symbol at bottom left. **George King** has similar envelopes with and without the recycling symbol (NB. This size matches that adopted for the C4 size manila Parliamentary envelopes with NVI E7, E11 & E12 stamps).

Manila paper, size 230 x 325mm., as previous envelope but with blue 'By air mail / Par avion' etiquette at top left, 'UNITED KINGDOM' under NVI and 'THIS ENVELOPE TO BE USED FOR / APPROVED EC DESTINATIONS ONLY' 12mm. 'Recycled paper' symbol at bottom left (Fig. 4).

Stamped to order Parliamentary envelopes with octagonal 1st class NVI stamp type E3a, and with 'House of Lords' and 'Portcullis' and 'Recycled paper' symbols at top left.

Manila paper, size 230 x 325mm., black stamp (24 x 24.5mm.), no phosphor bands, with bolder 15mm 'Recycled Paper' symbol at top left. With blue 'By air mail / Par avion' etiquette at top left, 'UNITED KINGDOM', under NVI and 'THIS ENVELOPE TO BE USED FOR / APPROVED EC DESTINATIONS ONLY', at bottom left (**Fig. 5**).



If anyone has examples of the above larger size octagonal NVI manila envelopes I should be very pleased to hear from them.

Manila envelopes recorded in issued form with NVI type E7, E8, E11 & E12 stamps.

Stamped to order Parliamentary envelopes with circular 1st class NVI stamp type E7, and with `House of Commons' and `Portcullis' symbol at top left on front and on backflap, and 14.5mm. `Recycled Paper' symbol on front at bottom left.

Manila paper, size 254 x 380mm., black 1st class 21mm. NVI stamp with 'POSTAGE PAID', with two clear phosphor bands and 50mm. back flap with pointed or curved corners (**George King** collection).

Manila paper, size 230 x 325mm., black 1st class 26mm. NVI stamp with 'POSTAGE PAID', with two 6mm. yellow phosphor bands and 'HC130' at bottom right and 44mm. back flap at left. Exists with and without a 'NAPM' recycling logo on the reverse under flap. **George King** has an example of the latter with clear phosphor bands (**Fig. 6**).

Manila paper, size 230 x 325mm., as previous envelope but 26.5mm. NVI stamp, with two 4.5mm. phosphor bands but **without** `HC130' at bottom right and 44mm. back flap at left

Stamped to order Parliamentary envelope with circular 2nd class NVI stamp type E8, and with `House of Commons' and 'Portcullis' symbol at top left on front and on backflap and 14mm. `Recycled Paper' symbol on front at bottom left.

Manila paper, size 230 x 325mm., black 26mm. NVI stamp with 'POSTAGE PAID' with one clear phosphor band and 40 or 45mm. back flaps (George King collection).


Stamped to order Parliamentary envelope with circular 1st class NVI stamp type E7, and with `Coat of arms / House of Lords' within oval at top left.

Manila paper, size 230 x 325mm., black 1st class 26mm. NVI stamp with 'POSTAGE PAID', with two 6mm. yellow phosphor bands and 45mm. back flap at right.

Stamped to order Parliamentary envelope with circular 1st class NVI stamp type E11, and with 'House of Commons and 'Portcullis' symbol at top left on front and on backflap, and 14.5mm. 'Recycled Paper' symbol on front at bottom left.

Manila paper, size 230 X 325mm., black 1st class 25.5mm. NVI stamp with 'ROYAL MAIL', two 6mm. yellow phosphor bands and 'HC130' at bottom right. Text with '100g and max depth 25mm' and 18mm. envelope symbol on 35mm back flap at right.

Stamped to order Parliamentary envelopes with circular 2nd class NVI stamp type E12, and with 'House of Commons' and 'Portcullis symbol at top left and on backflap, and 14.5mm. 'Recycled Paper' symbol on front at bottom left.



Manila paper, size 230 x 325mm., black 2πd class 25.5mm. NVI stamp type with `ROYAL MAIL', one 6mm. yellow phosphor band and `HC230' at bottom right and 40mm. back flap at right. Pale brown paper, size 230 x 325mm., as previous envelope but with one 4.5mm. pale pink? Phosphor band and 35mm flap at right (**Fig. 7**).

If anyone can add to this provisional listing I should be very pleased to be advised of the relevant information..

The latest Society auction included lot 307, a previously unrecorded uprated postcard used by the Commercial Union Insurance Company. The basic card is size g (CS231) with the 4d scarlet stamp L44 uprated to 6d with a 2d brown stamp L42 previously only recorded in size f (CS234).



Wrappers - Stamped to Order Issues Queen Elizabeth II

In 2006 **Peter O'Keeffe** reported (PSS Journal Vol.14 No 2 page 3), a KGVI uprated 1d + 1d reply paid letter sheet used by the National Blood Transfusion Service

where the reply half only had an additional ½d orange stamp L23 uprating the 1d carmine stamp L24. Neil Sargent now reports a later version with the 1½d green stamps L25 + L25 where the outward half is only uprated to 2d with one ½d adhesive stamp, while the reply half is uprated to 2½d with two ½d adhesive stamps. This sheet which is of pale green paper has the imprint '(5.18132) Wt. P.2230/8395 5,000 4/53 Hw.' on the reverse. NB. Although the above items are not technically wrappers they are listed in this section see note on page 84 of 'Collect British Postal Stationery(2007)'.



A single unused example of CP63 overprinted LEVANT is known but no used examples have been recorded to-date. It is unclear as to whether this item was ever available for use.



REPLY PAID POSTCARDS SURCHARGED IN TURKISH CURRENCY

The information given by the above listing enables a number of inferences to be drawn in relation to the availability and usage of overprinted reply paid postcards in the British Post Offices in the Levant.

- By far and away the most frequently seen reply paid postcard used in the Levant is the 1d King Edward VII 1902 issue (CP47) overprinted LEVANT. Out of the twenty-six usages listed seventeen are outward halves (cards 34-36, 39, 41-44, 48, 52-56,58), and nine are reply halves (cards 37,38, 40, 45-47, 49-51, 58), of which six are used as 'outward' halves (cards 37, 38, 45, 47, 51, 57).
- 2) Of the outward cards eight are used from Constantinople, six from Smyrna, two from Beyrout and only one from Salonica, while the of the six reply halves used as 'outward' halves, two are used

- from Constantinople (cards 44, 50), and four from Smyrna (cards 36, 37, 46, 56).
- 3) Of the reply halves used 'correctly' back to the Levant (cards 39, 46, 49, 50) two are addressed to Galata (cards 46, 50), one to Constantinople Deutsch Post (card 39) and one to Wodena, Turkey (card 49). Only one was used within the Levant from Smyrna to Constantinople (card 46)
- 4) The data suggests that King Edward VII reply paid cards overprinted LEVANT were available in Constantinople and Smyrna and on occasion reply halves were used and accepted as 'outward' halves.
- 5) Since only two examples have been recorded from Beyrout, one from Salonica and none at all from Stamboul it is questionable as to whether they were available at these post offices.
- 6) Currently there is no evidence to suggest that the later British Edward VII reply paid cards (CP57a and CP57b) were available either un-overprinted or overprinted.
- 7) Although a single example exists of the King George V 1d Downey head reply paid card (CP63) overprinted LEVANT (illustration lower left, p16), no other unused or used examples have been recorded to-date and thus it is highly unlikely that it was ever available for use ⁶.

REPLY PAID POSTCARDS SURCHARGED IN TURKISH CURRENCY

Only four used examples of the King George V 4½ piastre / 1½d reply paid postcard (**CP80**) have been recorded to-date. Two are reply halves used as 'outward' halves (cards 60, 61), and another was registered from Constantinople on 27.9.1923 and is clearly a philatelic usage on the last day the British Post Office was operational, but at least proves that these cards were still available (card 63).

Obviously further examples of reply paid postcard usage from the Levant are likely to come to light and readers are urged to send in details (preferably with an illustration) so that a fuller record can be established. Finally I should like to express my thanks to **Tony Stanford**, **Alexios Papadopoulos** and **Richard Malim** for their enthusiastic assistance with this study and making material available for illustration.

SWISS BUNDESFEIER CARDS 1910 TO 1938

I have read Ulrich Fehlmann's long illustrated article in the latest PSS Journal which I thoroughly enjoyed for its illuminating a different sector of postal stationery and the research that such an article entailed.

I decided to write and illustrate another well known, but as far I am aware unknown to the PSS Journal, a short feature on Swiss Bundesfeier cards. This is not meant to be authoritative in any sense, but just to show what can be found under the heading of postal stationery. How these fall under U. Fehlmann's classification I do not know, but they certainly have a picture/drawing on one side and an indicium/message area as can be seen further on in the article.

On 16th December 1909 the Bundesfeierkomitee was founded to promote activities associated with the celebration of the Swiss National Day - Bundesfeier - each 1st August, commencing in 1910. In some years just one card was issued, in others between two and five, In cooperation with the Swiss PTT the committee sponsored the printing and issue of picture postcards featuring Swiss historical and traditional scenes. These cards bore postage stamp imprints of five centimes green for the first few years

and then increased as postal rates rose with some special rates also printed. These postal stationery items continued until 1937 when the system altered in 1938 as Pro Patria adhesives were issued instead. The final issue overall was in 1960. The same designer, Karl Bickel, mentioned by U. Fehlmann, was used for some of these cards for the value tablet as may be seen.

Proceeds from the sale of these cards were used to fund various charitable activities - the charity is marked on the card. Some cards are overprinted Entwertet meaning they had been invalidated for postage. On a personal note generally I find the card designs rather dull and the subject matter uninspiring with the colours seeming muted and muddy, except for some of the issues taken from engravings. They certainly are the poor relation to the German cards of the Third Reich if you compare them.

Prices for these items vary. There is one dealer on eBay that sells them for around £5, others fetch £15-£20. Some go for £40-£50 while others are priced at over £100

but the majority seem to be at the lowest level. Some unused cards fetch more than used.

In 1910 the first card features William Tell and a soldier.

Some 300,000 were printed in litho, the proceeds going to those who had suffered badly in the recent floods.

Another card from 1915 – The Rutli Oath. This is a legendary oath of the Old Swiss Confederacy taken on the Rutli, a meadow above Lake Lucerne near Seelisburg. It was featured in the William Tell drama of 1804 by Freidrich Schiller.

The first mention of the Oath is in the White Book of Samen in 1470. Tschuld dates the event to 8th November 1307 which falls within the period of similar Treaties, such as the Federation Charter of 1291 and the Pact of Brunnen of 1315 (see cancel on the 1911 card). The Oath promises that three Oath Takers, Eidgenossen, will meet on every 1st August on the Rutli meadow and bring with them leading and brave men of the three cantons to decide on a common action plan.

The used card was posted from St. Gallen to England 28thth July 1915 (three days in advance of the actual release date) at the correct 10c rate.


For 1917 four different cards were issued – all in favour of the Red Cross.

For 1918 five cards were issued each showing a view of a Council Gathering. They are numbered by small figures in the top left hand corner – but cards also exist without a number. The charity is simply 'For our Soldiers'.


It should be noted that the postage rate has now been increased to 71/2c.

Both cards are view 1, the used from Kusnack has an extra 2½c adhesive added as it was not used until October 1921 when revised rates were in operation.

There was a change for 1928. Cards were printed with postage rates of 10c, 25c and 40c to reflect different rates of postage. The theme was 'Age' with two designs – an Old Lady with Young Girl and an different rates of postage. Old Man with Young Girl.






The printing of the 1937 Bundesfeier cards was the final issue of this long-running programme that commenced in 1910 using pre-printed postage values, ie postal stationery. With the issue of 'Fete Nationale' stamps, Bundesfeier cards no longer carried a postage stamp imprint but had to have an adhesive added to pay the postage rate. This ends this particular section of Bundesfeier cards.

These are samples of 1938 that show, top, an illustration of 'Flowers and Flags, and lower a 'Belltower' which note is a first day card uprated to England.



CERTIFICATES OF POSTING

I have recently been corresponding with a fellow collector, **John Newcomb** ⁽¹⁾, about the stamped to order certificates of posting that were produced in the 1970s and 80s. This is his story, which I think is interesting enough to publish.

"In the 1960s John Newcomb and some fellow members of the British Postmark Society (BPS) became irked by the small size and all the clutter on the little orange form P326, the Post Office's reference number for certificates of posting for letters and packets. (A charge was made for issuing certificate P326, but there was another little form for parcels and this was free.)

For the BPS members there was no clear space on form P326 for the ½d adhesive stamp or for the date stamp impression - important not merely from the collectors' viewpoint, but also for a clear record of the time and place of posting. So with official approval, some members of the BPS privately devised a bigger form on white paper with ample space for a stamp and postmark.


Then, not long before decimalisation, they commissioned the printing of a stamped to order version of the form with a 1d stamp (H&B L41) on the enlarged certificate, figure 1. This was not 100% successful in that the stamp was very dark (coloured olive) which did not allow the date stamp to show up clearly. After decimalisation in February 1971, the members ordered a further batch of certificates with the stamped to order stamps valued 1p, with either a single 1p stamp (H&B L50) figure 2 or two ½p stamps (H&B L49) figure 3.


These certificates seem to have created an interest well beyond the small circle of enthusiasts who commissioned them.

In the early 1980s (possibly July 1982) the charge for issuing certificates of posting was abolished. The late James Mackay stated that this was due to a ruling by the European Commission, but others claim it was as a result of a representation by the British Office of Fair Trading (OFT).⁽²⁾ It has not been possible to establish if either of these stories is correct."

(If one of our members can shed more light on this, please get in touch with the Editor.)

(1) John Newcomb worked for the Post Office in central London, and has been a member of the British Postmark Society for more than 50 years, serving on their committee for much of that time. As part of their studies, they wanted to collect clear postmarks from all the post offices scattered around the country, and in many cases one of the few ways to achieve this was to send a letter from each post office and seeking a certificate of posting.





(2) It is possible that the OFT were aware of a relevant EC ruling which could have prompted their objection to the fee. John Newcomb tells me he is quite certain that it came up during their negotiations with the OFT on the Code of Practice. They simply acquiesced - a small price to pay towards getting the OFT's agreement.



QUERY: Nigerian Aerogrammes 1948-52

Ray Harris writes "I was looking yesterday at back numbers and came across the request from John Bell (page 11, vol 18 no 4) for any information about McCorquodale records. Do you know if anyone responded?

I am looking for info on the sheet sizes (and anything else available) in relation to their printing of Nigerian aerogrammes in 1948-52."

[Editor: Looking back through my records, I did not have any feedback from the late John Bell's request. Can any member provide more specific information on the Nigerian Aerogrammes?]

Adrian Parker writes:

"Re Colin's article about Airletters with the Magi Illustration, (Two Stamped to Order Air Letters - PSS Journal August 2014), Adby's Catalogue of Aerogrammes lists 3 STO airletters with this image - the 2 mentioned plus one with a single 5p Machin embossed stamp - STO1a (m) to (o).

I have copies of all 3. The catalogue also lists the airletter without the picture with stamps going back to the 6d letterpress stamp L38. This suggests that the name on the airletter relates to the plain airletter and that the illustration is a later addition - possibly by a different hand."

Posting the Journal Abroad
